Prosecco DOC Borgo Alato, Brut NV- £39

Extra dry, clean fresh fruit nose, pure pulpy fruit with limestone and floral notes. 11% abv.

Justerini & Brooks, 250th Anniversary Cuvee Champagne - £83

France, extra dry, medium bodied, lemongrass, gingerbread and honeysuckle. 12% abv.

Philipponnat Champagne NV, Royale Reserve Rose Brut - £110

Dry, full and ample on the palate, with good acidity and a light astringency that brings out fruitiness. 12.5% abv.

Laurent-Perrier Héritage, France - £230

A complex blend of distinct vintages from the best Crus of Champagne and two grape varieties, Chardonnay and Pinot Noir. 12% abv.

Deposit and Prepayment

To confirm a provisional wedding reservation, we require a non-refundable 50% deposit at the time of booking. Once this deposit has been received, the Hotel considers your booking confirmed, and you have agreed to our terms and conditions. Full prepayment is due six weeks prior to your wedding. Should you wish to pay amounts towards the balance periodically, this is also acceptable.

Final numbers are required six weeks prior to your wedding. Once these are received, this is the minimum that you will be charged. Should your numbers increase, then we will do our best to accommodate your extra guests, and you will be charged accordingly. Should your numbers decrease after that time, you will be charged for the numbers confirmed six weeks before your wedding date.

Should there be any final balance at the end of your wedding, this should be settled before you depart the hotel, or by providing us with debit/credit card details so we can charge the balance.

Cancellation

Should you have to cancel your booking, the initial deposit is non-refundable.

Please see below for cancellation fees for the remaining balance.

- More than 60 days, 50% of wedding costs, payable before the wedding date
- 30 - 60 days, 75% of wedding costs, payable before the wedding date
- Less than 30 days, 100% of wedding costs, payable before the wedding date

Any live music or entertainment must be acoustic only. Please note there is no dance floor at Twr y Felin Hotel.

Our License prohibits the cash sale of alcohol after 12 midnight between Monday and Saturday and 10.30 pm on Sunday. The Management of Twr y Felin Hotel reserves the right to end service from 12 midnight or close the bar at 11.30 pm.

Hotel Property

The Management of Twr y Felin Hotel hold you responsible for the behaviour of your guests. You will also be held liable for any willful damage to hotel property and contents.
